DO YOU KNOW ... What we have to offer!

Bill Pay: Bill pay offers our members the ability to set up payments to come out of your account, either automatically or only once you have initiated it. This is a great way to get you monthly bills paid. For those that are the same amount every month you can set up a recurring payment. For those that change amount month to month you can go in and change the amount with the click of a button and get the bill paid. No need to visit several different sites to pay different bills. Also eliminates the need to pay postage!

P2P: Needing to pay someone any time any where? Take advantage of this quick and easy option through Bill Pay. It is the P2P (Person 2 Person) option! In your online bill pay section, select the pay an individual and you can send a transfer to anyone you are needing to pay, or as a gift. What ever the reason you can get them the funds fast and easy!

Repay: Repay is our online loan payment option. For those members that would like to pay the loan they obtain with us from another financial institution. You can set up one-time payment options for a small fee if you choose to use your debit card or you can use your bank account and routing number for no fee. Also no fee is assessed if you set up a scheduled monthly payment!

Text Alerts: Alert you when transactions post to your account, or if your balance is low. You have the ability to set up when, how, and why it sends alerts. To access this feature, log into your online banking, select the Alerts tab and complete! Set it up to email you or text you with low balance, withdraws, or deposits!

Dormant Account: If you received a dormant account letter, act now to ensure your funds do not go to the state in the escheatment process!
